Attention Shrimp hatchery operators: List of approved suppliers for import of SPF broodstock of *L. vannamei*

Hatchery operators who fulfill the conditions laid down in the guidelines notified by DAHD&F shall be allowed to import the SPF broodstock of *L. vannamei* for production of nauplii and PL. Import of SPF broodstock of *L. vannamei* shall initially be allowed only from the following approved suppliers short-listed by the committee set up for this purpose:

The import of broodstock shall be in accordance with the Guidelines issued by DAHD&F vide Notification S.O. 2402 (E) dated 15th October, 2008 for regulating the method of operation of aquatic quarantine for the import of *L. vannamei*, as well as the guidelines and safeguards required for hatcheries rearing SPF *L. vannamei* which are available in the website of DAHD&F.
